This information is submitted for a wholesale business account for the Company and to apply for open account credit terms. We, the undersigned, affirm that the Company is in the ongoing business of selling, installing, servicing or otherwise maintaining heating, air conditioning, sheet metal or electrical products and systems, and holds current and appropriate federal, state and local contractor and/or business licenses and permits as may be required, and will provide evidence or identification of same.

The Company agrees to make all payments when due according to Allred's Terms of Sale Policy. The account is payable at the headquarters office of Allred's Inc., 631 West Commerce Park Drive, Midvale, UT 84047, and interest of 1-1/2% (18% annually) will be assessed on all past due accounts. The Company understands that some materials will be delivered when we are not at the delivery site. The Company agrees to pay for these materials even though we were not personally there to accept delivery. The Company agrees to pay for all deliveries actually made and not rejected within five business days of delivery.

In the Company defaults on payments and Allred's Inc. determines it necessary to turn the account to a collection agency or attorney for collection, the Company agrees to pay the interest specified above, and all costs incurred in the collection of the account, including a collection cost of up to 40% of the principal balance, reasonable attorney's fees, and court costs. Collection fees are in addition to the account balance which may include finance charges. Such sum shall be assessed whether or not a judgment is rendered in favor of Allred's Inc. The laws of the State of Utah shall govern this Agreement. The federal and state courts of the State of Utah shall have exclusive jurisdiction of all disputes arising from this agreement. Venue for any lawsuit or dispute arising out of this agreement shall be in District Court of Weber County, unless Allred's Inc. otherwise chooses. Allred's Inc. may compel arbitration, at its own election, of any dispute between Allred's Inc. and customer. This arbitration shall be conducted in Ogden, Utah in accordance with the laws of the State of Utah.
